2. Receive Update From Cambridge Systematics

Strategic Programs and Feasibility Analysis. Jolene Hayes thanked everyone for his or her comments on the latest draft of this memo. She will be sending out another revised version of the draft and it is very close to be finalized.

Demonstration Project. Jolene indicated she is working with Matt Hanson at Caltrans on this. They are looking to get Volvo trucks through the Path Program and Telecon technology for the Demonstration Project (Demo). The Demo would involve a presentation and ride along. They are looking at early December 2016 for this Demo but the exact date is uncertain as the Volvo trucks just left to Canada and coordination needs to happen with the researchers (from UC Berkeley ITS). One possible route for the Demo would be from Richmond CA along I-580 to the Stockton area with further routing TBD within the Stockton area freeways. Jolene is looking to get a save-the-date out soon. Kim Kloeb asked about the technology and driver capabilities. It will be “driver assisted” technology for the Demo. There will be five trucks total in the Demo. Michael Sigala reminded the consultants to include the media for the outreach for the Demo. Cambridge is also compiling a report on the Demo technologies to be provided to the TAC.

Stakeholder Outreach. Jolene Hayes noted that performance measures are being worked on for the meeting. Michael Fischer continued to cover this item for both planning studies as a joint meeting is planned for Fresno COG on October 4, 2016 at 1pm. Michael Fischer noted they would use this meeting to reach out to a variety of public and private stakeholders. Providing background on the studies, reviewing findings to date and soliciting input from stakeholders is the key objective of the meeting. Break out sessions with maps and other visual aids will also be part of the meeting. Survey forms and mark up of maps will be included. A list of invitees was provided and TAC members were encouraged to further send and follow up with key stakeholders from their respective counties. Elizabeth Hahn inquired about the soliciting information on truck parking at the meeting, it will be covered. Michael Sigala noted he would invite all Valley EDCs at their monthly meeting on Friday. There will be a call in phone number for the meeting, however, attendance in person is encouraged.
