2. Update on Stakeholder Focus Groups Scheduled November 7-9th

3. Discuss Urban Rural Maps and Disadvantaged Areas for Each C. Rodier Jurisdiction

Sent maps of rural and urban census tract by county and received feedback for changes. Future maps will identify incorporated and unincorporated cities.

Madera: No Changes

*Note that the census tract identified as urban is only about less than 10% percent urban (far right side) and the rest is rural, however the small area that is categorized as urban is what puts it over the threshold so should be left as is. Please send Caroline a note of any other census tracts that have a similar condition.

<u>Fresno</u>: Change Clovis to urban. Will follow up with Moses and provide a map with cities and incorporated cities overlaid on top.

Kern: Change Delano to rural and South Taft to disadvantaged.

Merced: Added additional disadvantaged communities.

Kings: Will include Avenal as a disadvantaged community.

Tulare: Correct city names and change some tracts categorized as urban to rural.

<u>Stanislaus</u>: Change some tracts categorized as urban to rural. San Joaquin: Change some tracts categorized as urban to rural.

Elizabeth Forte: Suggested changing CES score criteria to 95% of greater because 75% is a low number.

4. Summary of Rural Transit Service in the Valley

Provided a list of addition data by census tracts. Partnering with a Betsy McGovern-Garcia from Self-Help Enterprises (has over 1,300 units), who will administer a survey to her residents in January to determine travel patterns.
