2. Receive Update From Cambridge Systematics

Existing and Future Conditions Revised Memo. Jolene Hayes noted a revised Existing and Future Conditions memo (emailed on May 25) was provided to the TAC with minimal comments received to date. She noted a May 8, 2016 Stakeholder meeting in Kern County with good feedback from participants. Some land use implications like fueling stations are to be added to maps as an example of feedback from the workshop.

Strategic Programs and Feasibility Analysis. Jolene noted a basic draft of the report and will issue it after the fourth of July weekend.

Demonstration Project. Jolene is trying to coordinate with LA Metro on this, and a couple of trucking/technology companies for a demonstration project from northern CA to southern CA going thru the Valley. She is still working on this for an end of the year event.

Stakeholder Outreach, July 14 Directors' Meeting. Jolene needed some more information on what to present. Michael Sigala noted the need for a status update and key findings to date, summarized by county. Michael Fischer noted he is coordinating between both studies and will get back to the group.

3. Other Items

California Sustainable Freight Action Plan. Jolene Hayes noted the study will incorporate pilot projects and other strategies for zero and near-zero emissions for freight. Land use implications and MPO leadership were noted as ways this plan wasn't like SB 375. Derek Winning noted a conceptual zero emissions freight corridor in the delta. Hector Rangel noted a meeting he attended with a lot of background info and he will share this with the group. Michael Sigala outlined the draft letter from the Directors and asked for feedback. Rob Ball noted the letter and indicated they have provided feedback in terms of updating the list of projects in the original TCIF. The pilot projects were briefly discussed. Kern COG and the Valley submitted pilot project concept ideas to ARB. The two Valley inland cargo depots that are under development in Shafter and Fishcamp (Stockton) were noted as unique. Both of these projects are in need of software development to maximize efficiency and perhaps this could be a role for ARB.
