DISCUSSION/ACTION ITEMS:

2. RTP/Sustainable Communities Strategies/Air Quality

R. Niblock

Ryan Niblock noted type four and type five off-cycle RTP amendments; Madera and Merced are currently working on amendments. Ryan would like to know if there are any additional amendments. Mr. Niblock presented a chart on timelines from the disapproval of the contingency measures for the 2018 PM 2.5 plan. SIP Highway funding sanctions are dependent on the Air District's contingency measures supplemental submittal. Ryan also noted the draft California Transportation Plan Guidelines and Regional Transportation Plan Guidelines will be posted on March 10th. Tom Jordan, SJVAPCD, noted the contingency measures supplemental submittal is more precarious than in the past; the EPA denial is untested, the timeframes are short, communication with EPA from affected partners is crucial.

3. Budget, Policy and Legislative Updates

State of California

G. Khouri

Gus Khouri noted approximately 24 pending bills of interest; brown act, gas tax suspension, and a few others were noted. Assemblymember Friedman is holding a stakeholder meeting on AB 2237 & 2438, two CAPTI compliant bills from last session. The Valley Voice discussion was tabled to closed session.

Washington D.C. J. Covino

Jen Covino noted the congressional directed spending process (senate) and community project funding requests (house), the house appropriations committee has released guidance which includes a reduction in the maximum funding amount and a nexus requirement for projects. Mrs. Covino gave an update on the timing for submittals with members. Upcoming Crissy grants were noted, with some eligibility for inland ports.

4. SJV REAP Program

R. Phipps/M. Sigala

Michael Sigala noted technical assistance is ongoing. The RHNA Insights GIS tool is up and running. AFFH workshop series is ongoing. The REAP Committee for Housing held a meeting last week. Robert Phipps noted the licensing arrangement with HDR for the RHNA Insights tool for MPOs and jurisdictions. Robert further noted the third application funds, which are pending, but will be provided by HCD in an amount not to exceed 50 percent at this time.

Robert Phipps noted that in October 2020, a 28-month contract with Sigala Inc was entered for REAP management activities. A contract extension is now needed as the REAP program was extended by one year. The requested action is for a Directors' recommendation to the Fresno COG Board to amend the Sigala Inc contract through June 30, 2025 in an amount not to exceed \$250,000:

Diana Gomez, District 6, noted SR 168/China Peak closures, I5 and SR58 are open. Clean California II applications are due April 28th. Clean California day of action is March 17-27, 2023. Sustainable Planning Grant applications are due next week. Reconnecting Highways to Boulevards guidelines are being completed with applications due later this year. The RFP release date for the SR 99 Multimodal Corridor is still pending legal review.

Marlon Regisford, District 10, noted road closures and snow removal in higher elevation roads. He noted many RAISE letters of support for Valley projects signed by the Caltrans Director.

This bill would additionally require each Solutions for Congested Corridors project nomination to demonstrate how the project would contribute to achieving the state's greenhouse gas emission reduction targets. AB 7 (Friedman) Transportation: funding: capacity projects	3/27/23 Assembly Appropriations	This bill would require, on and after January 1, 2025, the project selection process for each transportation project that would be funded, at least partially, from specified funding sources, including the State Highway Account, the Road Maintenance and Rehabilitation Account, and the Trade Corridor Enhancement Account, to incorporate specified principles.
