# 2. RTP/Sustainable Communities Strategies/Air Quality

# Ryan Niblock

Ryan Niblock provided an update on conformity issues related to adopting the 2025 FTIPs, stating that there will be a grace period approved by the EPA and partner agencies to use EMFAC2017 until November 2024, with mandatory use of EMFAC2021 after December for RTP amendments. Hot Spot concurrence meetings with Caltrans/FHWA/EPA are ongoing. One of the main challenges with the Hot Spot assessment process has been the lack of consistency across different Valley MPOs. Leslie from the California Air Resources Board requested MPO target recommendations by October 31st for the next round of SB 375 greenhouse gas targets. The Committee agreed on a valley-wide vs. individual MPO approach for GHG reduction targets. Ryan will coordinate with MPO staffs, focusing on the impact of slower population growth on meeting future targets and focusing on the positive actions taken to date by each MPO, trying to make the targets as realistic as possible. The group will revisit the previous analysis, identifying issues beyond their control affecting their ability to meet the targets. Each MPO will need to update their sections. The modeling teams from all eight MPOs will need to produce work.

Gus Khouri expressed concerns about the state's Air Resources Board's GHG figures, noting that they unfairly penalize the region for issues beyond their control, such as the through-put of goods movement and agriculture. Robert and Ryan agreed, pointing out that the state's housing policies exacerbate vehicle miles traveled (VMT) and GHG emissions due to the jobs-housing imbalance. Terri King discussed the challenges of meeting future targets due to stagnant or declining population growth.

Lastly, Ryan mentioned the need for additional funding for the Trinity Consulting contract to cover additional costs resulting from the additional work related to EMFAC, Hot Spot, and target setting. The group agreed to allow Trinity to use up to \$20,000 of existing contingency and to prepare an updated cost estimate for a refined scope of work for review at the next meeting. The group also provided direction to MPO technical staff to work with Ryan on a valley-wide response to the CARB request.

### 3. Budget, Policy, and Legislative Updates

#### State of California **Gus Khouri**

Gus Khouri provided an update on the legislative front, highlighting three main bills: AB 1335 (Zbur), which would require MPOs to include in the SCS the total number of new housing units necessary to house all the population of the region over the course of the planning period of the RTP in addition to the total number of new housing units necessary to house the 8-year RHNA projection; and AB 2290 (Friedman) and SB 1216 (Blakespear), which would prohibit Class 3 bikeways from being built in ATP-funded projects. Gus mentioned that there was robust opposition to these bills and that they were not expected to move forward. He also noted the Legislature would reconvene on August 5 and that the Governor has until September 30 to review and sign bills. In addition, Gus proposed kicking off the 2025 legislative platform exercise earlier in the year to build better relationships with legislators and staff and discuss gas tax successor options. Gus recommended adding a placeholder for the next Directors' meeting to discuss these items.

#### Washington D.C. Jen Covino

Jen Covino discussed political developments in Washington, DC, including President Biden's announcement not to run for reelection and Vice President Harris's expected selection of a running mate this week. Trump's Vice-Presidential candidate JD Vance was in Fresno this week, talking with Valley farmers. Jen will advise Directors on preparations for transitions on Capitol Hill in January 2025, regardless of who is elected. She also provided an update on the FY 2025 budget and appropriations process, noting that there were likely to be issues between the House and Senate. She shared that the Senate had scaled back some requests from California's 2 Senators in the THUD bill, and that only one of the projects is related to transportation. Jen also emphasized the importance of including space in the legislative platform to advocate for plan approvals from federal agencies.

# 4. Committee Updates

a. Valley Legislative Affairs committee (VLAC)

Robert provided updates on committee reports and the VLAC meeting. Gus mentioned an upcoming Senate Rules Committee hearing for Leanne Eager's reappointment to CTC, which Robert will attend in person.

# b. SJV Swap Meet

Ofelia introduced herself as the new chair of the Swap Meet, which serves as a resource platform for programming personnel from the MPOs. Last month, the group discussed FTIPs. The next meeting will focus on RTPs and future plans to improve the OA process. Ryan provided a heads up about a guidelines workshop for the Solutions for Congested Corridors program and emphasized the importance of advocating for projects not to be ineligible based on timing of plan adoptions.

### c. Housing and Land Use

Kim Anderson shared that there were no updates on housing but expected more to report in the coming months.

#### d. Travel Modelers Group

Rob Ball announced that the Modelers group would be meeting on August 19th. The group will discuss the Rural Induced Travel Study, which has received pushback. He reminded Directors of the match requirement for each MPO ranging between \$5k and \$30k.

#### 5. SJV Reap Program

**Robert Phipps** 

Robert discussed the REAP program, which officially ends on December 31st. He emphasized the need for invoices from jurisdictions by September 30th to facilitate the closeout report. He also announced that an additional \$732,829 would be used to complete TCAG's full allocation for the REAP program and a housing element implementation guide. Robert warned that any unspent funds would be clawed back after December 31st. He also mentioned ongoing work on the small lot planning study and the objective design standards guide. Finally, he reported that 24 jurisdictions had requested technical assistance, and the next technical advisory committee meeting was scheduled for August 13th.

# 6. San Joaquin Valley Annual Policy Conference

**Stacie Guzman** 

Elizabeth Forte reported for Stacie Guzman that the tentative dates for the Annual Policy Conference are April 9-11, 2025, with UC Merced and Downtown Merced as possible venues. MCAG will begin coordinating with VRPA, and the official dates will be released soon.

## 7. Caltrans Directors' Report

Michael Navarro | Grace Magsayo

Michael Navarro, District 6, announced Jim Perault's promotion, the hiring of an engagement coordinator Mimi Odemi, and the launch of Caltrans' engagement portal. He stated that the SR 99 Comprehensive Multimodal Corridor Plan (CMCP) virtual public workshops have been completed

and public feedback is currently being reviewed and project lists compiled. Terri mentioned the reopening of State Route 41 after bridge replacement work. Grace Magsayo, District 10, congratulated MCAH and SJCOG on recent grant awards of over \$3 million. Discussions with MCAG on gap closures are underway.

# 8. California High-Speed Rail

# 9. San Joaquin Joint Powers Authority - Passenger Rail

**Michael Hanebutt** 

Michael Hanebutt noted that he has completed a summary highlighting rail projects in the Valley and is working on RTT Vision one-page summaries for each MPO. He discussed the need for strategic messaging around California's high-speed rail project in light of upcoming elections and added that these summaries can be used in the letter to CARB discussed in Item 2. Jen Covino highlighted the potential scrutiny of the HSRA projects given the election cycle and emphasized the importance of focusing on local benefits in the Valley.

# 10. San Joaquin Valley Air Pollution Control District

**Tom Jordan** 

Tom Jordan reported on the approval of a 2.5 PM plan by the Environmental Protection Agency (EPA), a rescinding of the plan, its resubmittal, and a pending ozone contingency plan. Tom Jordan noted the 2012 Attainment Plan for PM 2.5 standards is going to their board this month for approval. They are still working on the contingency issue with EPA. Approval by the EPA is needed by November; otherwise, there will be highway sanctions.

# 11. Miocar EV Car Sharing

Michael Sigala

No formal report was provided; however, Kim Anderson shared the success of the Sustainable Transportation Equity Program in San Joaquin County.

See below for a review of developments at the federal level of interest to the Central Valley. Topics include Fiscal Year (FY) 2025 budget and appropriations, a reminder on Direct Pay from the Internal Revenue Service (IRS), and current and upcoming federal funding opportunities from the U.S. Department of Transportation (DOT). # FY 2025 Budget and Appropriations

Congressional leaders are deliberating the length of a Continuing Resolution (CR) that the House of Representatives and the Senate intend to consider upon the return of Members of Congress from the August recess. Lawmakers in both chambers are scheduled to return to Capitol Hill on September 9, 2024 and will have just three weeks to pass a stopgap measure before funding for the current fiscal year is set to expire on September 30, 2024. Some conservative members, including the House Freedom Caucus (HFC), have advocated to keep the federal government funded through the first or second quarter of early 2025, providing lawmakers elected to serve in the 119th Session of Congress the opportunity to finalize Fiscal Year (FY) 2025 appropriations working with a new presidential administration. However, the move would put House Republican leadership at odds with House Appropriations Committee Chair Tom Cole, as well as Senate and House Democrats, who have remained steadfast in their preference to pass spending bills leading up to or during the lame-duck session. Leadership is also debating which policy provisions, if any, will be included in the CR, including the current extension of the Farm Bill that will also expire on September 30, extensions of other expiring expirations requested by the Administration, and immigrant voting legislation requested by conservative Republicans. We will be sure to keep you updated on the status of the CR over the weeks ahead.

# **Direct Pay**

As the Biden-Harris Administration celebrated the recent second anniversary of the *Inflation Reduction Act* (P.L. 117-169), the Internal Revenue Service (IRS) reminded local governments and other entities interested in claiming tax incentives available through the





Direct Pay provisions of the law for projects placed in service in 2023 to complete the mandatory pre-filing registration process. As a reminder, Direct Pay (or "elective payment") was authorized by the IRA to allow units of local government and other tax exempt and governmental entities to receive a payment equal to the value of new and expanded tax credits authorized by the law for a variety of clean energy projects. Eligible incentives are organized by project area and outlined in a fact sheet. This comprehensive White House website outlines the process to claim those payments, while this table offers a review of eligible projects and the amounts of the corresponding tax credits.

Pre-filing registration is a requirement for eligible taxpayers to receive direct or elective payment of these tax credits. The registration number generated by the pre-filing registration tool must be included on a taxpayer's annual return and filed before any payments can be received. IRS recommends that taxpayers submit pre-filing registration "at least 120 days prior to when the organization or entity plans to file its tax return on which it will make its election." The agency continues to host office hours to assist project sponsors in navigating the pre-filing registration process, and we have included information and registration links for upcoming sessions below:

- September 4, 2024 (1:00 p.m. to 2:30 p.m. ET): Registration
- September 18, 2024 (1:00 p.m. to 2:30 p.m. ET): Registration
- October 2, 2024 (1:00 p.m. to 2:30 p.m. ET): Registration

The National League of Cities (NLC) and Government Finance Officers Associations (GFOA) published a brief highlighting how communities can take advantage of tax incentives for clean energy projects eligible under the Direct Pay. We encourage all units of local government, special district governments, and your partners in tax-exempt nonprofit organizations to review this opportunity and consider how these tax credits may be applicable and beneficial to your clean energy projects under development.

Valley Models Assessment - Update from F&P (Mike Wallace)
 Mike Wallace reported on the status of the model assessment. There are a number of
 pieces still being worked on. Mike will send out an email requesting some additional
 information from the MPOs and is reviewing ARB comments on SCSs to help address them.

## 2. ARB SCS updates check-in (Rob Ball)

- 2022 SCS Review & Technical Methodology (Update from each MPO/open discussion) & Target Setting Recommendations Deadline Oct 31st.

  Each MPO reported on Status of CARB 2022 SCS Review Process. Only a few MPO's (Kern, Fresno, Stanislaus) have received email approvals (not a formal approval), some more than 1-year ago, many are waiting on a response from ARB on their first submittal. Each MPO reported on Technical Methodology for the 2026 RTP. Many MPOs are beginning to develop with a few further along. Kern has submitted theirs.

  Each MPO reported on Target Setting Recommendations **Deadline Oct. 31**. MPOs are hopeful to incorporate latest model updates and data, but would definitely need more time. The Group would like to push for a later date to submit recommendations to ARB. Ryan Niblock mentioned that they and Trinity will be working on a joint submittal for the Valley COGs. Only Fresno COG thought that they would be able to do their target setting using their 2026 RTP/SCS model. The rest are likely to use their 2022 models if more time is not granted by ARB.
- ii) SB 150 Dashboard Response Letter/s
  Deadline for comment letters is August 28<sup>th</sup>, 2024. Kern COG raised concerns about the difference between the dashboard and the RTP/SCSs requiring a disclaimer or footnote to avoid potential confusion between the two numbers. No volunteers to try to compile comment letters by the deadline. Kern COG said they would bring the issue up to CALCOG and request that they submit a letter with our concerns.

- 3. Auto Operating Cost & Conformity Outreach/ Other conformity updates (Alex Marcucci) Alex will be sending out an email update later this week.
- 4. Valleywide Traffic Count Program vs Big Data Streetlight Demo (Rob Ball/Steve Ferguson StreetLight)
  - A presentation was made by StreetLight. TCAG, MCTC, and Stanislaus County have licenses for StreetLight Data. The V-TRANSFRM Climate Adaptation grant from Caltrans will include the purchase of big data like that provided by StreetLight.
- Rural Induced Travel Study Announcement (Rob Ball)

- 6. Update on V-TRANSFRM Climate Adaption Grant (Roberto Brady) Roberto provided an overview of the project and emailed a table of each agency's match amount. The up-coming Kick-off meeting with Caltrans is soon. The grant includes funding for each MPO to do pre-environmental 30% conceptual design and cost estimation on a freight related climate adaptation/co-benefit project to be selected in part by the public outreach process.
- 7. Modeling Micro-Transit (Kasia Poleszczuk/open discussion)
  Discussed possibility for modeling Micro-Transit. The Group consensus along with input from consultants, was to use data to adjust off-model for Micro-Transit.
- 8. Statewide Travel Model Updates (Caltrans update Steven Vo) New combined statewide travel model and freight model scheduled to be released in March 2025. # REAP Update September 5, 2024

- The REAP program will end on December 31, 2024. All invoices from MPOs to Fresno COG are due by September 30, 2024.
- A July 2024 advance invoice request for \$732,829 has been approved HCD. This amount will be used for an Objective Design Standards guide for Valley jurisdictions, and for TCAG's multijurisdictional housing element.
- An August advance invoice request for \$749,000 has been submitted to HCD. This amount will be used for multijurisdictional housing element cost overruns in Tulare (\$519k), Kings (\$80k) and Merced (\$150k) counties.
- ADU and AFFH only Technical Assistance to Valley jurisdictions is available utilizing the following consultants:
  - Precision Engineering (ADU)
  - ➤ VTA (AFFH)

28 jurisdictions have requested technical assistance to date: *Arvin, McFarland, Atwater, Kingsburg, Bakersfield, Clovis, Stanislaus County, Hughson, Wasco, Stockton, Madera County, Madera, Merced County, Tulare County, Kings County, Selma, Lodi, Parlier, Porterville, Merced, Gustine, Dos Palos, Lemoore, Woodlake, Lindsay, Dinuba, Farmersville, and Exeter.*
