1. ACTION: Review and Approve the Draft 2025 Federal Platform

David Gellman



David Gellman, Cavino, Smith, and Simon discussed the following:

- ✓ An update on planning for the Valley Voice trip to Washington, D.C., including meeting scheduling and space arrangements.
- ✓ Key Priorities: Continued emphasis on securing federal funding for STBG, CMAQ, metropolitan planning, and farm-to-market road projects. Streamlining permitting and simplifying grant processes remain top priorities.
- ✓ Emerging Air Quality Issue: Robert Phipps, Executive Director and Vice Chair of the Directors' Committee, Fresno COG, highlighted urgent concerns regarding the rescission of California air quality standards, resulting in a statewide project freeze. Discussion centered on the need to incorporate this issue into the federal platform and engage directly with the EPA during Valley Voice.
- ✓ High-Speed Rail & Funding Reallocation: Jay Schlosser, Executive Director and Member of the Directors' Committee, Kern COG, Member Rudy Mendoza, TCAG, and others emphasized the opportunity to reallocate \$4B in rescinded federal funds toward Valley priorities such as Highway 99 and I-5 improvements, intercity passenger rail, and other corridor projects.
- ✓ Gus Khouri, Kouri Consulting, advocated for a nuanced approach to balance continued support for the Merced–Bakersfield high-speed rail improvements, while advocating for reallocation of funds toward regional needs. Gus Khouri provided updates on state-level challenges, including Cap and Trade funding uncertainties, SB 375 extensions, and CARB's rigid approaches to emissions reductions.
 - A need was identified to engage with the newly formed San Joaquin Valley Caucus to advocate for regional priorities.
 - Proposals to create a state rail system that would complement the high-speed rail project and improve connectivity across California.

- ✓ Action Plan: Jay Schlosser, Kern COG, volunteered to contact Congressman Fong to clarify his stance on reallocating high-speed rail funds.
- ✓ Directors agreed to draft a prioritized list of Valley projects for potential funding.

2. ACTION: Recommend Approval of the Draft Final 2025/26 San Joaquin Valley Regional Agencies Overall Work Program, Budget, and Meeting Schedule to the SJV Policy Council

Stacie Guzman & Georgiena Vivian



Stacie Guzman, Chair, Directors' Committee, MCAG, introduced the item and requested that Georgiena Vivian, SJV Coordinator, review the significant section changes from the current OWP. The following highlights were noted:

- ✓ Budget Adjustments: Increase in Valley-wide coordinator funding (VRPA) to \$180K due to expanded responsibilities, addition of a Policy Council & Directors retreat, and additional Policy Council and Executive Committee meetings. Legislative advocacy contract for Gus Khouri increased from \$120K to \$126K. Total costs rose from \$573K to \$634K for FY 2025.
- ✓ Directors Retreat: Added to the OWP to strengthen organizational function, communication protocols, and goal setting.
- ✓ Adoption: The 2025-26 OWP, budget, and schedule revisions were discussed.

Vice Chair Vito Chiesa made a motion, StanCOG, to recommend approval of the FY 2025/26 OWP, Budget, and Schedule to the Policy Council, which Member Jose Rodriguez, MCTC, seconded. The motion passed.

3. ACTION: 2026 San Joaquin Valley Policy Conference - Postpone to 2027

Stacie Guzman informed the Executive Committee that the Directors' Committee is recommending postponement of the 2026 Policy Conference until 2027 due to a lack of a host. Directors discussed revising the

hosting rotation to include Kern County and Madera County for future conferences. Ms. Guzman also discussed the possibility of holding conferences less frequently (e.g., skipping years when RTPs are adopted).

The House and Senate Appropriations Committees recently announced Community Project Funding (CPF) and Congressionally Directed Spending (CDS) requests selected for inclusion in Fiscal Year (FY) 2026 spending bills. We have provided the Committees' selected project lists below as well as a review of projects from the Central Valley that were requested by members of the Congressional delegation. Projects sponsored by the San Joaquin Valley Regional Planning Agencies or their partners are highlighted in bold for your consideration. Please note that, for the projects to be funded, lawmakers will need to include the allocations in any eventual deal on the spending bill in which they are housed, and that bill must then be passed by both chambers and signed into law.
