Chair Stacie Guzman called the meeting to order at 10:00 a.m. She welcomed the Directors and participants and confirmed that the October minutes would be considered for approval. She also welcomed Kate Miller, the new Interim Executive Director, with the Stanislaus Council of Governments (StanCOG).

Chair Guzman called for approval of October 2, 2025, minutes.

A motion was made by Vice Chair Robert Phipps, FCOG, and seconded by Member Ted Smalley, TCAG. The motion passed.

Ryan Niblock, SJCOG, provided updates on SB 375 and upcoming GHG target discussions. He noted that extensive statewide conversations are underway and that Valley agencies must stay aligned before the November 6 joint meeting with:

- ✓ CARB
- ✓ CTC
- ✓ HCD

Director **Jay Schlosser**, Kern COG, raised concerns about recent developments in Shafter, where the California High-Speed Rail Authority made unexpected presentations proposing changes to previously negotiated commitments.

Key points from his remarks included:

- ✓ Kern and Shafter were blindsided by CHSRA outreach.
- ✓ Concerns that CHSRA is attempting to back away from commitments made as part of litigation settlements.
- ✓ Fear that CHSRA may pursue a “faster/cheaper” project at the expense of agreements with communities.
- ✓ Media attention is escalating; Schlosser received outreach from 60 Minutes.
- ✓ Local boards in Kern range from “neutral to hostile” toward CHSRA; such actions worsen trust.
- ✓ He strongly requested that Valley Directors include language urging CHSRA to honor prior commitments.

Chair Guzman expressed support and acknowledged similarities to issues MCAG recently faced.

b. Clean Air Act Waiver Recission – Lockdown/Endangerment Finding Update	<i>Ted Smalley & Ryan Niblock</i>	<input type="checkbox"/>

Ryan Niblock, SJCOG, provided the following information:

- Need to prepare for implications related to potential lockdown conditions.
- Directors emphasized ensuring planned projects remain eligible and protected under conformity rules.
- Director Smalley, TCAG, stressed the importance of explicitly supporting expedited SIP amendment adoption to avoid project delays.
- Alex Marcucci, Trinity Consultants, reviewed the regulatory timeline and ongoing interaction with EPA Region 9.
- Ryan confirmed staff is revising policy language to reflect Directors' feedback.

3. Legislative Updates

a. **State**Gus Khouri

Gus Khouri, Khouri Consulting, reviewed the new Cap-and-Invest (formerly Cap-and-Trade) budget package:

- ✓ AB 1207 extends the statewide program and includes an \$85 million fund for climate-focused technology and innovation.
- ✓ Opportunities may exist for the Air District or Valley agencies to access funds for climate-solution deployment.
- ✓ He noted the upcoming revenue stability in auctions may create excess revenue that could benefit TERSIP, LCTOP, or the Farmer Program.

Gus also confirmed he would incorporate the Directors' requested language on:

- ✓ Supporting expedited SIP amendment adoption.
- ✓ Protecting planned transportation projects from delays.
- ✓ Strengthening statewide recognition of Valley needs.

b. **Federal**Jen Covino

Jen Covino, Covino, Smith, and Simon, reported that the federal government has reopened and that the Senate is preparing to introduce another minibus funding package as early as next week. This package is expected to include the Transportation-HUD (THUD) appropriations bill, which houses the region's DOT and HUD earmark requests. She cautioned that while the timeline could slip past Thanksgiving, congressional leaders are working quickly, and cooperation between the House and Senate remains strong. Jen committed to sending bill text and confirmation of funded earmarks as soon as they become available.

Jen also highlighted a significant new issue: the U.S. Department of Transportation will revoke more than 17,000 non-domiciled commercial driver's licenses (CDLs) issued by California for noncompliance with federal work authorization requirements. She asked whether any Valley transit agencies were experiencing operational impacts.

Stacie Guzman shared that MCAG has been focused on impacts from the federal shutdown, particularly a surge in demand for transit tokens that forced the agency to temporarily offer free transit using measure funds. She will follow up regarding CDL impacts.

Kim Anderson and Kate Miller asked clarifying questions about earmarks, the appropriations schedule, and whether CDL revocations could affect paratransit or shuttle contractors. Jen explained that the primary impact will be on drivers whose CDLs are revoked, not transit funding. California could lose \$140 million in federal grants, but those funds typically do not flow to local operators. She also noted ongoing Senate discussions about Affordable Care Act tax credit extensions, though the House remains unlikely to support them.

4. Committee Updates

Robert Phipps, Kayley Clay, Kim Anderson, Rob Ball

a. ***Valley Legislative Affairs Committee (VLAC)***

Vice Chair, Robert Phipps, FCOG, reported that the Valley Legislative Affairs Committee (VLAC) has been suspended indefinitely. He explained that the committee currently lacks staff leadership to run it, and that strong, ongoing discussions between Valley lobbyists, Directors, the Executive Committee, and the Policy Council are already covering legislative issues effectively. Because these conversations are happening directly within existing structures, he does not anticipate holding VLAC meetings unless the Directors choose to reinstate the committee and staff it differently. No additional VLAC updates were provided.

b. ***SJV Swap Meet***

Kayley Clay, KCAG, reported that the SJV programmers recently held an in-depth discussion on how each region selects and programs projects for STIP funding as they prepare upcoming RTIPs. The group maintains a standing agenda item to coordinate on the 2026 RTP and 2027 APTA, ensuring information sharing, questions, and status updates across MPOs.

She noted they also discussed the process for amending Tribal Transportation Improvement Program and Federal Lands Highway projects into regional FTIPs, in accordance with new guidance from Caltrans. Additionally, programmers reviewed the list of federal earmarks successfully repurposed by Valley MPOs and discussed next steps for ensuring those earmarks are programmed into the FTIPs where needed.

The next SJV programmers meeting is tentatively scheduled for December, after the RTPA and CFPG meetings.

c. ***Housing and Land Use***

Kim Anderson, SJCOG, reported that the Housing and Land Use Committee met on October 21. Given the extensive legislative and housing updates already provided earlier in the meeting, she offered a brief overview. The committee continues to explore recent legislation and is taking a deeper look at the potential development of a VMT mitigation bank or exchange, with conversations ongoing.

Kim noted that MPOs are now receiving detailed, and sometimes unexpectedly intensive, questions from HCD regarding REAP 2.0 annual reporting, especially regarding how projects connect to current and future SCS work. Many agencies are still waiting on project amendments and approvals, and the overall back-and-forth with HCD has been slow and time-consuming.

She added that the committee will bring a January agenda item on RHNA consistency, as agencies begin preparing draft reports in anticipation of adopting new RTPs next year. The group will continue coordinating with legislative partners and others working on land use and SCS-related issues.

d. ***Travel Modelers Group***

Robert Ball, Kern COG, noted that the group's next meeting is next Monday (November 17), and will review air quality-related issues, as well as a presentation/update on the Vision Eval Pro and V-Transform grant projects.

5. SJV REAP Program Michael Sigala & Robert Phipps

Robert Phipps, Vice Chair, FCOG, provided the update regarding REAP 2.0:

- ✓ Despite budget approval, no agency has yet received contract extensions from HCD.
- ✓ This delay is concerning, given the state's "shaky" financial situation.
- ✓ Directors were advised to bill early and often to avoid potential funding risk.
- ✓ The REAP 2.0 deadline remains June 2026.
- ✓ All jurisdictions should continue processing invoices promptly to keep projects on track.

Chair Guzman, MCAG, thanked Robert for the "sage advice."

6. Caltrans Directors' Report Michael Navarro, D6 & Grace Magsayo, D10

Michael Navarro, Director, Caltrans, District 6, reported several significant accomplishments and ongoing initiatives in District 6:

- ✓ The successful completion of the SR 99 Comprehensive Multimodal Corridor Plan, developed collaboratively with Valley partners, SACOG, and District 3. This plan covers a 300-mile corridor and fulfills an ITIP condition tied to the Madera 99 South construction funding, which is anticipated to begin this fiscal year. Navarro thanked all Valley agencies for their partnership.
- ✓ A series of tours and site visits conducted with state legislators and CTC commissioners:
 - A walk assessment with Assemblymember Baines.
 - A tour for CTC commissioners highlighting projects in Madera and Merced Counties.
 - A recent tour with Assemblymember Soria, joined by Director Taylor.These tours showcased significant projects, including SR 99 improvements and downtown community enhancements, reinforcing statewide support for Valley priorities.
- ✓ Briefed the Directors on Caltrans' participation in the new SAFE (Statewide Action and Facilitation on Encampments) Task Force, which focuses not only on cleaning encampments but connecting individuals to services and installing hardscape features to prevent repopulation.
 - District 6 recently held a successful SAFE event in Fresno.
 - Another is planned for January.
 - Encampments significantly impact maintenance budgets, and Caltrans encourages local agencies to reach out when they encounter issues.
- ✓ With IGRA expiring on September 26, Caltrans and CALSA are seeking early input in advance of federal reauthorization. A Transportation Funding Sub-Working Group meeting is scheduled for December 1, and districts are available to answer questions.

- ✓ Reported progress in the draft ITIP:
 - The North Madera 6-lane project continues forward with \$17.9 million identified for design and right-of-way.
 - A new project, the SR-99 Managed Lane environmental clearance, has been added, aimed at clearing the corridor for strategic future managed lanes, including closing the remaining four-to six-lane gap between Pixley and Tulare.
- ✓ The CTC will hold the 2026 SB 1 Guidelines Development Kickoff Workshop on November 20, covering LPP, TCEP, and SCCP opportunities. It was noted that the new managed lane strategy could open additional SCCP funding pathways for the region.
- ✓ BUILD (formerly TIGER/RAISE) NOFO is expected soon; Caltrans requests a 14-day notice for letters of support.
 - Sustainable Transportation Planning Grants:
 - Virtual office hours were held on October 23.
 - One-on-one support remains available.
 - Applications are due November 21.

Michael closed by inviting agencies to contact District 6 if they would like help coordinating additional tours for elected officials or need support on grants or encampment issues.

Caleb Brock, Caltrans, District 10, thanked Michael for his comments and noted that he had no additional details to provide.

7. California High-Speed Rail CHSRA Representative

A report was not provided.

8. San Joaquin Joint Powers Authority – Passenger Rail Ahdel Ahmed

Ahdel Ahmed, SJJPA, announced that Amtrak San Joaquin has officially transitioned to its new brand, "Gold Runner," as of this month. SJJPA is hosting an in-person Gold Runner launch event in Stockton the following day from 11 a.m. to 1 p.m., in partnership with Caltrans. All Directors should have received an invitation.

He reported that the Chief Officer search is still underway, with interviews continuing. Longtime leader David Lopari remains in the interim position until the selection is finalized, and an update may be available within the next month.

Regarding Valley Rail, there are still no recent updates. SJJPA continues working with individual counties on service phasing, budgeting challenges, and next steps. The agency intends to produce a complete, region-wide expansion plan showing future phases and priorities for the Valley Rail program.

9. San Joaquin Valley Air Pollution Control District Mark Montelongo

Mark Montelongo reported that the Air District continues to actively engage with CARB on SIP-related issues, particularly in light of the state's recent mobile source waiver actions. He noted that the District held a governing board study session last month to review several strategic topics, including
